Procedure/Policy

This policy has been created to ensure compliance with all State and Federal regulations relative to the safe transportation and or handling of any shipment placed in the care, custody and control of any authorized QC driver.

Redacted QC Security Plan - 49 CFR 172.800, 172.802, 172.804

Security Assessment Surveys (SAS) have been completed on all company and affiliate locations, the scope of the surveys assisted QC with formulating a comprehensive security program for our unique environment. Continued SAS's will be conducted routinely, or based on any event or elevated threat level by the DHS, as well as in conjunction with CTPAT recertification (which typically occurs on a triennial basis). An SAS may also be conducted at the discretion of QC's Vice President of Safety and Security or the Director of Security. Information contained within the QC Security Plan - SAF-906-225 is confidential, the redacted Security Plan - SAF-906-225A is for drivers operating under QC's authority as well as for public dissemination. The QC Security Plan is the property of QC's Vice President of Security and Safety and is retained in our corporate office, the plan is managed by the DOS.

The QC Security plan includes but is not limited to the following information.

- Personnel Security, comprehensive criminal background checks, employment verification, MVR query's
- Driver Security Kit including: State of the art King-Pin lock, Air Brake lock and
- Facility/customer security including but not limited to CCTV and or access control programs
- Information Technologies and Cyber Security, maintaining state of the art protection of proprietary information via electronic transmissions
- 100% ELOGS (Isaac) monitoring HOS compliance of operators and tractor locations
- Exclusive design and creation of an external pump lockout clamp which will be attached to all of our vessels to prohibit unauthorized tampering or discharge of products. The inexpensive appendage along with the other products in the QC Driver Security Kit (full

 allows us to ensure unparalleled levels of protection to our nation, and to our customers
 within the entire supply chain, regardless of turnover at any level due to normal attrition

Driver Training Requirements - 49 CFR 172.704

Every QC driver upon successful completion of the hiring and background check processes, must also successfully complete a four day 40 hour training curriculum in one of our five schools located throughout the U.S. and Canada. Comprehensive video and classroom education is conducted along with hands-on training with QC equipment and all material is presented by QC certified Master Trainers. Recurrent training and corrective action training modules are also employed throughout a driver's tenure with QC.

- Comprehensive on the job training with driver trainer versed on relative commodity
- Issuance of Personal Protection Equipment (PPE) and detailed instruction on usage
- QC emergency response procedures relative to but not limited to: spills, accidents, contaminations and thefts
- All drivers are fully trained on QC's Security program including but not limited to: risks
 associated with HAZMATs through possession and transportation, recognition and
 response to security related threats, customer related security requirements/plans, Law
 Enforcement Organization (LEO) and First Responder notifications as well as
 communication to QC management
- Comprehensive explanation of OSHA and EPA regulations and the impact of HAZMAT releases on our environment
- HM 126 training is conducted prior to drivers' first dispatch, as well as mandatory OJT
 assigned to new drivers as mandated by and documented by QC Master Trainers
- Recurrent training as required by law for all HAZMAT drivers every three years
- All records/documents relative to the driver's history and pedigree is maintained by corporate while employed by QC or approved affiliate and 90 days upon separation of employment
